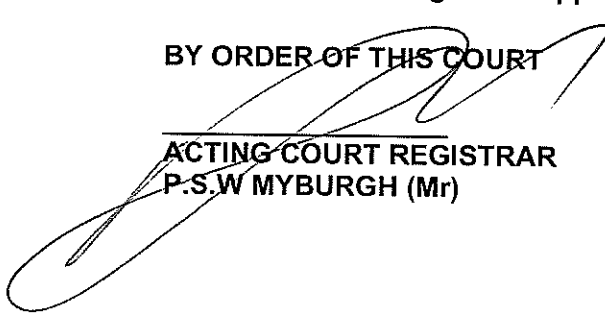
IT IS ORDERED THAT:
