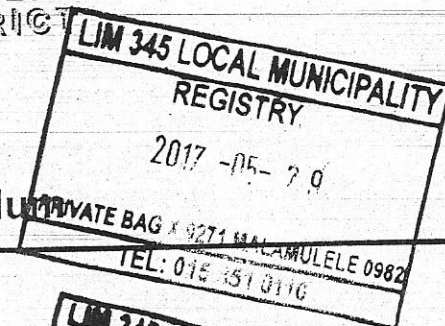

1. Purpose.

To update the Executive Mayor about the current information regarding the application of the establishment of a new health facility at Dumela community.

2. Background

The Dumela Developmental Task Team has submitted a follow up community regarding the application of a health facility establishment dated the 28 November 2011 to the former MEC for Health. The follow up communicate indicate the period of application in the years between 1994 and 1997. The establishment of a health facility is to provide access of Primary Health care services to a population of **25875** and provide services to the following villages:

1. Dumela Village 4419
2. Mulamula Village 5007
3. Nhombelani Village 3985
4. Muswani Village 4093
5. Xhigamani Village 4080
6. Xhihosa Village 4291

APPLICATION FOR NEW CLINIC PROJECT DUMELA COMMUNITY.

The situational analysis was conducted the distances from the nearby Primary Health care facilities and referral hospital have been reflected namely:

1. Malamulele Hospital 24 km
2. Mphambo Health Centre 18 km
3. Tlangelani clinic 8 km
4. Mukhomi clinic 14 km

Vhembe District Department of Health established a working relationship with community during the process

The Vhembe District Health Department (Primary Health Care) made an analysis and it was found that there is a need for a health facility in the area as the community is facing a serious of health challenges, namely

Burden of disease HIV&AIDS

Non communicable diseases -Hypertensions


-Diabetes



FOLLOW-UP ON THE HEALTH CENTRE WHICH WAS GRANTED TO OUR COMMUNITY, DUMELA VILLAGE UNDER MULAMULA TRIBAL AUTHORITY BETWEEN 1994 AND 1997

1. The above matter bears reference.
2. Dumela Village is found in Ward 17 of Morris Chauke in Thulamela Municipality, Vhembe District.
3. Between 1994 and 1997 our community was granted the Health Centre which was supposed to be erected in Dumela Village to cover six villages which do not have either Clinic or Health Centre which are as follows: Dumela Village, Mulamula Village, Nhombelani Village, Muswani Village and Xigamani Village as well as Xihosana Village therefore Dumela Village is in the centre of all the mentioned villages thus why it was to be constructed in Dumela village but it was in vain till now though these villages still continue to struggle to access health facilities as they have to go to far places like Mdabula Village, Mphambo Village and Malamulele Hospital travelling +/-15 to 25 kilometers.
4. Here to follow are the honorable people who were delegated by the Department to come and assess the place whereby stand no:306B was eventually approved as the good site for construction: **Matron Makaukau** from Malamulele Hospital was the one who was leading the delegates, **Doctor Mathebula** was the one who was supposed to be in charge of the Health centre and the former Member of parliament in the integrated government of Gazankulu and Lebowa, **Mr Bernard Misindu** from Mulamula Village was amongst them as well. Unfortunately because of poor administration we lost the letter which was given to us.
5. Your co-operation in bringing service to the people is highly projected in this regard.


